Presentation Lengths

Most concurrent sessions are 90 minutes, with the exception of one 60-minute concurrent session on Wednesday, November 19. Please refer to the information emailed to you to confirm the format of your presentation. It will be one of the following five formats outlined below.

Presentation Formats

PowerPoint is the preferred presentation format, but PDF is acceptable as well.

CCSA will preload presentations on laptops with Windows operating systems in the presentation room.

Changes to presentations made after November 4 will not be preloaded on laptops in presentation rooms or on the conference app.

You are welcome to hand out any paper materials required for your presentations or workshops. If paper materials are required, it will be the presenter's responsibility to prepare and print sufficient quantities.

You will also be able to add handouts in the conference app when you submit your presentation, which can be shared electronically.

Technical Information

You cannot use your own computer during the presentation or workshop.

All concurrent sessions will be held in individual rooms, each equipped with a laptop, podium (lectern), microphone and projector with screen.

You will be receiving an email that asks whether you require any additional equipment along with instructions on how to respond.

Meeting Workshop Objectives

Please ensure that the learning objectives you identified in your abstract are achieved by the end of your workshop.

Workshops are designed to engage participants in both thought and action. Please ensure that participants in your workshop have time to practice, explore and discuss the objectives, as appropriate, so they are better equipped to implement their learning when they are back at their place of work.
